# TRANSCRIPTION OF LONGCOT ENCLOSURE DOCUMENT 1796

Henry Augustus Biedermann and John Davis were appointed Commissioners to carry out the allotting and inclosing of the open common land, fields, meadows and pastures of Longcot following an Act of Parliament in the Reign of King George 111. At this time the public roads were named, and the cost of repairing roads and fencing fields was charged to land owners.

MINUTES of the PROCEEDINGS of the Commissioners named and appointed in and by an Act of Parliament made and passed in the thirty sixth year of the reign of his Majesty King George the third for deciding allotting and inclosing the Open Common Fields Common Meadows Common Pastures and other Commonable and Waste lands and Grounds within the Hamlet or Township of LONGCOT in the Parish of Shrivenham in the County of Berks

At the first Meeting of Henry Augustus Biedermann and John Davis two of the Commissioners named and appointed in and by an Act of Parliament made and passed in the thirty sixth year of the reign of his present Majesty King George the third entitled "An Act for dividing allotting and inclosing the Open Common Fields Common Meadows Common Pastures and other Commonable and waste lands and grounds within the Hamlet or Township of Longcot in the Parish of Shrivenham in the County of Berks" held at the House of William Lucas called or known by the name or sign of the Barrington Arms in Shrivenham aforesaid this eighteenth day of July 1796 Notice of such Meeting having been first given agreeable to the Directions of th said Act.

At this Meeting the said Henry Augustus Biedermann and John Davis took and subscribed the following oath before they proceeded in the execution of the said Act vizt.

I do swear that I will faithfully impartially and honestly according to the best of my skill and judgement execute the Trusts reposed in me as a Commissioner by virtue of an Act of Parliament made for inclosing the Open Common Fields Common Meadows Common Pastures and other Commonable and waste lands and grounds within the Hamlet or Township of Longcot in the Parish of Shrivenham in the County of Berks

#### So help me God

Ordered that James Crowdy of Highworth in the County of Wilts and William Ward the younger of Great Faringdon in the County of Berks gentlemen be and they are hereby appointed our Joint Clerk and Treasurer to attend us at our Meetings and to prepare engross and inrole our Award and to do and execute all other Acts belonging to the Office of Clerk and Treasurer to us the said commissioners in the Execution of the said Act in cases of the like Nature

Ordered that William Church of Lewknor in the County of Oxford Gentleman be and he is hereby appointed our Surveyor for making a perfect Survey and admeasurement of the Lands and Grounds by the said Act directed to be divided allotted and inclosed and of the old inclosed lands lying within the said Hamlet or Township to be exonerated from Tythes and to do and transact such other business as shall be necessary for him to do and shall be ordered by us the said commissioners And we do hereby ratify allow of and confirm what the said William Church has already done towards such survey and admeasurement

Ordered also That our said Clerk do cause a copy of the following Notice to be affixed on the Principal Door of the Church of Longcot aforesaid on Sunday next and to be advertized in the Oxford Journal and Reading Mercury twice in each

#### LONGCOT INCLOSURE

Noptice is hereby given that a Meeting of the Commissioners appointed for putting in execution an Act of Parliament passed in the last session entitled An Act for dividing allotting and inclosing the open common Fields Common Meadows Common Pastures and other Commonable and waste lands and grounds within the Hamlet or Township of Longcot in the Parish of Shrivenham in the County of Berks will be holden at the House of William Lucas being an Inn called The Barrington Arms situated in Shrivenham aforesaid on Monday the fifth day of September next at eleven o'clock in the forenoon; and that all persons claiming any right property or interest whatsoever in or upon the lands or grounds by the said Act intended to be divided allotted and inclosed or any part thereof are hereby required pursuant to the said Act to deliver in and lay before the said Commissioners at the said Meeting their said respective claims in writing together with FECRIERS specifying the number of yard land acres and common rights claimed by them respectively and that immediately after said claims shall be so delivered in the same will be open for inspection of the Proprietors at large of the said common fields and that any objections which may arise to any of such claims the said Commissioners will onSaturday the 10th day of the same Month at the House aforesaid proceed to hear and determine. At a Meeting of the Commissioners named in and appointed by the foregoing Act of Parliament holden on Monday the fifth day of September 1796 at the Barrington Arms in Shrivenham in the County of Berks pursuant to the adjournment of the Commissioners at their last Meeting.

John Stone of Pull Court in the County of Worcester gentleman a Commissioner Appointed for putting in execution the said Act of Parliament before he proceeded to put the said Act in execution took and subscribed the oath specified in and appointed by the said Act to be taken by every person acting as such a Commisioner.

The Commissioners agreeable to Notice affixed on the Principal Door of the Church of Longcot and advertised in the Oxford Journal and Reading Mercury received many claims and Terriers of Lands and Commons within the said Hamlet and adjourned their Meeting until the next Morning the sixth instant then to be held at the same place.

The Commissioners met this Morning pursuant to their adjournment of yesterday and ircured and qualited the whole of the lands and commons this and the two following days and continued their Meeting till the ninth day of this instant September in which time they also adjusted and abstracted the claims delivered and ircured the lands in order to ascertain the different private and public roads necessary to be set out in and over the lands and grounds by this Act directed to be divided and inclosed and ordered the same to be staked out by the surveyor accordingly and transacted other matters incident to and attending the said Inclosure.

Ordered that our Clerks do advance the Surveyor the sum of sixty pounds towards defraying the esspense he has already put to

No. 2 One other Public Carriage Road or Driftway of the like breadth of forty feet beginning near the church in the village og Longcot and extending through the said village and along the open fields ia an Northward direction and entering the first described public road at the Division between Great and Little Knapps being part of the public road leading from Longcot to Faringdon and hither to called Kings Lane Way

No.3 One other public Road or Driftway of the breadth of forty feet beginning near the said church in Longcot aforesaid and extending Westward in its present direction along the WEST and Green and taking a Southwards direction over the WEST EAD Cow Common to a Gate at the bottom of the said Common in the Liberty of Knighton being part of the road leading from Longcot to Knighton

Showenhan No.5 One other public Bridle and Private Carriage Road of the breadth of thirty feet branching out of the third described public carriage road near the West Corner of Hill Meadow and extending in a Westward direction under the hedge of the said Hill Meadow to a Gate in the Liberty of Beckett being part of the Public bridle and private Carriage road leading from Longcot to Shrivenham.

Ordered that this Meeting be adjourned to Monday the thirty first day of October next at the Barrington Arms at Shrivenham.

The Commissioners named in and appointed by the foregoing Act of Parliament met at the Barrington Arms at Shrivenham in the County of Berks on Monday the thirty first day of October 1796 pursuant to their adjournment at their last Meeting and proceeded in the Execution of the said Act

At this Meeting the Commissioners received requests in writing from the several Proprietors and their Agents for the situation of their allotments and proceeded in calculating the different properties of the Proprietors and received consents in writing for exchanging several Messuages buildings and old inclosures and schemed out the allotments to the several proprietors subject to such alterations as may be necessary hereafter to make therein on account of the claims made by the proprietors of the great tithes of one ninth part of the commonable land which they conceive themselves intitled to under the said Act of Parliament but such claim not appearing satisfactory to the said Commissioners they stated the following Case for the opinions of Francis Burton Esq a counsellor and ordered the same to be laid before him in order to procure his opinion thereupon by the next Meeting of the said Commissioners and that a printed copy of the said Act shall be laid before the said Francis Burton with the said Case

#### CASE

Within the Hamlet of Longcot there are two Commons containing about 400 acres which time immemorially have been solely appropriated to the depasturing of Horses cows and sheep. Under the clause in for 12 of the Act the Improprietors of the Great Tithes claim an allotment of one ninth part of the said Commons beside the claim which the Vicar has in the said Commons for his Vicarial Tithes. It is to be observed that about one twentieth part of the lands to be inclosed under the Act are free of corn and hay tithes. ???. Whether the Commissioners are bound by the Act to allot to the Improprietors of the Great Tithes any share of the Commons or Waste Lands.

The Commissioners made and signed the following order for vacating leases vizt.

We the Commissioners named in and appointed by an Act of Parliament made and passed in the thirtysixth year reign of his present Majesty King George the third intitled an Act for dividing alloting and inclosing the open common fields common meadows common pastures and other commonable and waste lands and grounds within the Hamlet or Township of Longcot in the parish of Shrivenham in the County of Berks do hereby in pursuance of the power given to and vested in us by the said Act Order and appoint that all leases and other agreements at rack rent of all and every or any part of the lands grounds and premises by the said Act intended to be divided allotted and inclosed and of all messuages buildings homesteads pardens orchards and old inclosed lands held with the same or which may be exchanged by virtue of the said Act shall cease determine and be utterly void at the respective times following that is to say As to and concerning the said lands grounds and premises by the said Act intended to be divided allotted and inclosed on and from the twentyfourth day of December next: And as to and concerning the messuages buildings homesteads gardens orchards and old inclosed lands held with any of the said lands grounds premises by the said Act intended to be divided allotted and inclosed And as to and concerning the messuages buildings homesteads gardens orchards and old inclosed lands which shall be exchanged by virtue of the said Act on and from the thirteenth day of February next. Given under our hands the fifth day of November one thousand seven hundred and ninety six.

At the Meeting it is also ordered that the Surveyor do forthwith attend and show to the several Proprietors their respective allotments as schemed out by the said Commissioners in order that they may enter thereon to plough and cultivate the same subject to such alterations or diminitions as the said Commissioners may find it necessary to make in or to the said allotments or any of them; And in case the said allotments shall not be confimed to the respective Proprietors to whom the same are set according to the scheme proceeded upon at this Meeting or shall be altered in extentor situation then the person or persons by whom or at whose expense such allotments shall be ploughed or cultivated shall have and receive such recompense and satisfaction for the said ploughing and cultivation as the said Commissioners shall judge an equivalent for the same.

The Commissioners ordered that at their next Meeting to be holden on the twelfth day of December next the lessors or owners or lesseesor tenants who shall consider themselves intitled to any satisfaction for or on account of their leases or agreements at rack rent of all or any of the lands by the said Act intended to be inclosed and of any mess uages buildings homestead gardens orchards and old inclosed lands held with the same or which may be exchanged by virtue of the same Act being vacated by the order or appointment for that purpose made by the same Commissioners at this Meeting do have notice to deliver in an account of the satisfaction required by them respectively for vacating such leases or agreements as aforesaid in order that the same may be taken by the said Commissioners into consideration.

Ordered that the Clerks do collect and bring in at the next Meeting of the sadi Commissioners all bills of expenses and charges incurred in the execution of the said Act of Parliament and of obtaining and passing the said Act

This Meeting which was continued from the first day of October last till the fifth day of November following inclusive is hereby ordered by the said Commissionersto be adjourned to Monday the twelfth day of December next at the Barrington Arms aforesaid.

On the twelfth day of December 1796 at the Barrington Arms at Shrivenham in the county of Berks to which time and place the last Meeting of the Commissioners for carrying into execution the Act of Parliament passed in the 36th year of the reign of his present Majesty intitled "An Act for dividing alloting and inclosing the open common fields common meadows common pastures and other commonable and waste lands and grounds within the Hamlet or Township of Longcot in the Parish of Shrivenham in the County of Berks" was and stands adjourned.

Henry Augustus Biedermann on of the **giad** Commissioners appeared to execute the powers of the said Act; and he being the only Commissioners then and there attending did by virtue and in persuance of the authority in him vested by the said Act of Parliament adjourn the said Meeting of tha said Commissioners so appointed by the said former adjournment to be held this day as aforesaid to the next day being Tuesday the thirteenth day of December instant at nine o'clock in the forenoon at the Barrington Arms in Shrivenham aforesaid then and there to be holden for carrying into execution of the said Act.

At the Barrington Arms in Shrivenham on Tuesday the thirteenth of December 1796

Henry Augustus Biedermann and John Davis two of the Commissioners for carrying into execution the before mentioned Act of Parliament met pursuant to the last adjournment for the purpose of executing the powers of the said Act.

The following Opinion has been received on the Case Ordered at a former Meeting to be laid before Counsel vizt

The Clause respecting the Impropriators allotments is very obscurely penned but in my opinion the Commissioners according to the construction which ought to be put upon it are bound to allot to the impropriators of the Great Tithes of corn grain and hay a share equal in value to one ninth of so much of the commons and waste lands as are not exempt from corn and hay tithe notwithstanding the use to which they have been applied in their state of pasturage; But in order to judge whether the twentieth part of the commons and waste lands which is appendant or appear tenant to the exempt twentieth of the arable ought or ought not to yield its ninth to the Impropriators allotment I think it will be necessary to inquire into the nature and grounds of the exemption. For if it be an exemption from all tithes as well great as small in consideration of a modus ,I think the exemption will extend to the commons and one twentieth part of them will consequently be exempt from yielding to the Impropriator any allotment. The direct contrary to this will be the case/according to the doctrine in Doncaster vs Watson/if the exemption be only from corn and hay in consideration of a modus. If the exemption be absolute and not in consideration of any modus whatever I think the question is more disputable but my opinion is that such an exemption even though it should be included no more than the corn and hay tithes would, nevertheless extend to the commons and privilege a twentieth part of them from yielding any allotment to the Impropriator.

In conformity to the foregoing opinion of Counsel directions were given to the Surveyor to make calculations and adjust the lines of the allotments accordingly and to produce the same to the Commissioners at their next meeting.

At this Meeting an objection having been made by Mr James Morrell in the behalf of Edward Cooper Clerk to the Allotmenters scheme out for him the same taken into consideration and the allotment ordered to be adjusted accordingly-

Ordered that this Meeting be adjourned to Thursday the twenty second day of December instant to the Kings Arms in Oxford

At the Kings Arms in Oxford on Thursday the 22<sup>nd</sup> of December 1796 Henry Augustus Biedermann and John Davis two of the Commissioners met pursuant to the last adjournment when the Surveyor agreeably to the directions given him at the last Meeting produced his calculations and the lines of the allotments as altered which were examined and approved of by the Commissioners and directions given to him to stake out the allotments accordingly.

The Commissioners received further instructions as to exchanges which are to be adjusted at the next Meeting, they also allotted the Boundary fences on each persones Estate and having continued their Meeting to Saturday the 24<sup>th</sup> day of December instd, they adjourned the same until Thursday the fifth day of January next then to be holden at the Barrington Arm in Shrivenham.

Mr John Stone one of the commissioners appeared to execute the powers of the said act in pursuance of the last adjournment and he being the only commissioner then present did by virtue and in pursuance of the authority in him vested by the said Act adjourn the said Meeting of the Commissioners to the next day being Friday the sixth day of January instant at nine o'clock in the forenoon at the place above mentioned then and there to be holden for carrying the said Act into execution.

#### Barrington Arms Shrivenham Friday the sixth of January 1797

John Stone and John Davis two of the Commissioners met pursuant to the last adjournment and received the lands and premises agreed to be exchanged and estimated the value thereof and also viewed such alterations to be made therein as appeared to them necessary. Also inspected and correct the calculations made by the Surveyor under the orders of the last Meeting; likewise made a rate which is hereafter set forth and proceed otherwise in the execution of the Act. And having continued this Meeting till Saturday, the seventh of January adjourned the same to Monday the twentieth of February next at the Crown Inn at Faringdon in Berks.

The above mentioned rate is ordered to be collected and paid before the next Meeting of the Commissioners.

Ordered that the Surveyor do make out the respective quantities of each occupied lands in the fallow field sown. Also of the High Ground mown and of the Commons Homesteads and old inclosures occupied from May day 1796.

The Commissioners appointed for putting the foregoing Act of Parliament into execution met by adjournment at the place and time above mentioned and ordered the sums of money hereunder specified to be paid on or before the thirteenth day of April instant to William Ward and James Crowdy the Clerks to the said Commissioners by the several persons hereunder named being owners of lands by the said Act intended to be inclosed according to the rates made by the said Commissioners and hereafter set forth for and towards defraying the charges and expenses of obtaining and passing the said Act and incidental to putting the same into execution and of making and putting in repair the roads set out by the said Commissioners under the said Act and of making the fences directed by the said Commissioners to be made for inclosing and ring fencing the allotments to the Impropriators of The Great Tithes and the tithes of Wool and Lamb and to the vicar for his Glebe and vicarial tithes.

The said Commissioners appointed James Crowdy to be Surveyor of the Public Carriage Roads by the said Commissioners set out and directed to be fenced under the Act with the salary of ten pounds per annum for his trouble in forming completing and putting into repair the said roads.

Ordered that William Doulton and Michael Messer who have agreed to make the boundary fences of the Tithe and vicar's allotment be paid at the rate of eleven shillings and six pence per perch each perch containing twenty four feet for digging and making the ditches planking quicksets, and erecting substantial posts and rails on both sides of the said quicksets, for inclosing and ring fencing the said allotments which payments the Clerks to the said commissioners are ordered to make out of the monies to be received by them from the Proprietors of lands intended by the Act to be inclosed in pursuance of the foregoing order of the said Commissioners made at this Meeting.

Ordered that the clerks do out of the said monies receivable by them under the said order forthwith advance and pay to William Church as the Surveyor the sum of one hundred and twenty pounds and to the said William Poulton and Michael Messer the sum of one hundred and forty pounds upon account.

The said Commissioners having taken into consideration what rents or sums of Money ought to be paid by the Tenants or occupiers of lands and Estates inclosed and exchanged respectively by virtue of the said Act for the life and occupation of such of the said lands and Estates as they have quitted the profession of in pursuance of the order of the said Commissioners made for vacating their respective Leases thereof have ascertained and fixed that the rents received or payable by such Leases or agreements shall cease and determine on and from the fourteenth day of November last up to which time the said rents are to be paid.

The Commissioners fixed and ascertained that the following sums of money should be paid to their respective impropriators of the great Tithes as a compensation for the Tithes of the lands within the said Hamlet which in course should have lain fallow but were planted with corn viz to the sum of fourteen pounds and fourteen shillings to William Hemeys and his wife for the Great tithes arising within the East end tithing and the sum of seventeen pounds to Ann Farupe(?) for the great tithes arising within the West end tithing.

The Commissioners read over and examined the Draught of their award.

William Church the Surveyor was sworn to the truth of his Survey and Admeasurement laid before the Commissioners for the purposes of the Act.

This meeting which was continued to the ninth day of April and then adjourned to Monday the twenty ninth day of May next then to be holden at the Kings Head Inn at Gloucester.

#### At the Kings head Inn in Gloucester the 28 May 1797

The Commissioners appointed by the foregoing Act of Parliament met the Day and year at the place above mentioned pursuant to their last adjournment, and proceeded in examining the ingrossment of their award and settled the Schedule of the Rents – payable to the Vicar in lieu of small tythes of several cottages, or tenaments gardens and orchards the owners whereof have not other lands sufficient to compensate for the same. The said Commissioners also took into consideration what allowance should be made for Blagrove Esq. Towards the expence of making the private road set out and awarded to be made to his allotment and ordered that he be paid the sum of forty pounds by their Clerks as compensation for the same.

The said commissioners also took into consideration several other maters relative to the Inclosure previous to the Execution of their Award. The Commissioners executed their award on the 3<sup>rd</sup> Day of June 1797 to which day they continued this meeting.

Ordered that the Clerks pay to William Church the Surveyor the sum of ninety one pounds eight shillings in discharge of the balance of his bill of charges.

John Stone and John Davis two of the Commissioners appointed by the foregoing Act of parliament met at the place and on the day above mentioned, pursuant to their notice for that purpose publickly given in the Church or Chapel of the hamlet of Longcot agreeably to the said Act and of which Meeting Notice in writing was given signed by the Clerk to the said Commissioners and affixed to the door of the said church or chapel for upwards of eight days previous to the said Meeting.

It appearing to the Commissioners that the sum of twelve hundred and twenty pounds which they ordered to be raised and paid by the several proprietors towards the expenses of making and putting in repair the roads by them set out and of the surveyors salary for his trouble about the same will not be sufficient to answer and discharge such charges and expenses they have made a rate for defraying those charges and expenses; which is as follows (viz.)

We the Commissioners appointed for carrying into execution an Act of Parliament passed in the thirty sixth year of the reign of his Majesty King George the third for dividing allotting and inclosing the open common fields common meadows common pastures and other commonable and waste lands and grounds within the hamlet or township of Longcot in the parish of Shrivenham in the County of Berks do hereby order and direct that the several persons hereunder named being proprietors and owners of lands by the said Act intended to be enclosed do on or before the nineteenth day of May next pay or cause to be paid the several sums of money hereunder specified as set against their respective Names unto William Ward the younger of Faringdon in the County of Berks and James Crowdy of Highworth in the County of Wilts for or towards bearing and defraying the Charges and expenses of forming and making and putting in repair the roads and ways by us set out by virtue of the said act and of the surveyors salary for his trouble in and about such roads and ways it appearing to us that the sum of twelve hundred and twenty pounds which we the said Commissioners by writing under our hands bearing date the third day of April one thousand seven hundred and ninety seven ordered and directed to be paid by the said several proprietors and owners for or towards the said charges and expenses will not be sufficient to answer and discharge such charges and expenses. Witness our hands this seventeenth day of April one thousand and eight hundred.
